<b>November 15</b>	<b>Board of Commissioners, Budget meeting, 7:30 p.m.</b> Budget Review for revisions. *BUDGET MUST BE AVAILABLE AT LEAST 20 DAYS PRIOR TO ADOPTION per Section 1701 of First Class Township Code. In order for the Board to adopt the Budget at the December 13th Legislative meeting, the budget must be available for citizen inspection by December 7th. The Budget is made available at the Furness Library, the Township Building, on the Township Website and will be advertised on the Township Cable Channel.
