Covid-19 Policies & Safety Plan for Nether Providence Township Summer Camp 2021

Pick-up/Drop-off procedure

Staggered Pick-up/Drop-off by ages groups.

Toileting/hand washing

The Camp will be using the NPE bathrooms closest to the gym and only these. Campers will follow all school procedures for bathroom use.

Hand sanitizer will be available to all groups and counselors will encourage frequent washing and sanitizing. Nether Providence Township Summer Camp staff will sanitize high touch surfaces daily.

Foodservice

All students and staff will always wear masks, except when eating/drinking and during periodic mask breaks which will take place outdoors with at least 6 feet of distance between campers. While 6 feet between campers may not be feasible at all times, student seating will be distanced, and counselors will encourage physical distancing throughout the day. On Special treat days Campers will have snacks outside 6ft apart under tents or on the field.

Camp organizational structure

To limit interactions between campers we have made some format and logistical adjustments to camp this year:

- Students will be in groups of no more than 22 people (up to 20 students and 2 staff) for most of the camp time.
- Camps will be in the same small group for the duration of the camp. No Intermixing of groups.

Positive or suspected positive cases and response

I think or know I had COVID-19, and I had symptoms.

You can be around others after:

- 10 days since symptoms first appeared and
- 24 hours with no fever without the use of fever-reducing medications and
- Other symptoms of COVID-19 are improving*

*Loss of taste and smell may persist for weeks or months after recovery and need not delay the end of isolation.

I tested positive for COVID-19 but had no symptoms.

- If you continue to have no symptoms, you can be with others after 10 days have passed since you had a positive viral test for COVID-19.

For Anyone Who Has Been Around a Person with COVID-19

- Anyone who has had close contact with someone with COVID-19 should stay home for 14 days after their last exposure to that person.
- The best way to protect yourself and others is to stay home for 14 days if you think you have been exposed to someone who has COVID-19. Check your local health department's website for information about options in your area to possibly shorten this quarantine period.

However, anyone who has had close contact with someone with COVID-19 and who meets the following criteria does NOT need to stay home.

- Someone who has been fully vaccinated within the last three months and shows no symptoms of COVID-19.

Or:

- Someone who has COVID-19 illness within the previous 3 months and has recovered and remains without COVID-19 symptoms (for example, cough, shortness of breath)

General Guidelines

Nether Providence Township Summer Camp 2021, will be following CDC Guidelines for Youth & Summer Camps, including – mask wearing, small groups, and majority of our activities outdoors. Our integrated camp themes include many of our most popular activities and projects.

Families are asked to self-screen children prior to arriving at camp each day, ensuring campers do not have a temperature above 100.4 F and are not experiencing COVID like symptoms.

Temperatures will be taken at camp if symptoms develop, and early pick-up may be requested.

People with COVID-19 have had a wide range of symptoms reported – ranging from mild symptoms to severe illness. Symptoms may appear 2-14 days after exposure to the virus.

People with these symptoms may have COVID-19:

Fever or chills

Cough

Shortness of breath or difficulty breathing

Fatigue

Muscle or body aches

Headache

New loss of taste or smell

Sore throat

Congestion or runny nose

Nausea or vomiting

Diarrhea

This list does not include all possible symptoms. CDC will continue to update this list as we learn more about COVID-19.

Nether Providence Township Summer Camp always involves lots of outside time for campers. Most Activities will be held outdoors under tents and other special projects will take place outside when feasible.

All students and staff will always wear masks except when eating/drinking and during periodic mask breaks which will take place outdoors with at least 6 feet of distance between campers. While 6 feet between campers may not be feasible at all times, student seating will be distanced, and counselors will encourage physical distancing throughout the day. In the event of a bad weather conditions the camp will either closed for the day or utilize multiple indoor open areas to maintain the 6ft rule while inside for all staff and campers.

Shared equipment will be sanitized between uses.

We are monitoring CDC and PA state guidance for summer camps.

Policies will be updated as CDC regulations change.
