Nether Providence Township's Winter 2021-22 newsletter is packed with information about events in and around our community this winter, township news, and general, helpful information. Fall always is a busy time for Nether Providence's Board of Commissioners and administration. Crafting the next year's budget, wrapping up the year's legislative agenda, and routine business all compete for our attention. This year was busier than most and included movement on legislation, grant awards, and public projects worth sharing here.

Providence Road Sidewalk Construction - in November, the Commonwealth of Pennsylvania approved Nether Providence's most recent grant application for Providence Road sidewalk construction. November's \$500,000.00 grant award brings the total grant funding for Providence Road sidewalk projects to \$1,250,000. We hope to break ground on the first phase of construction (installing a new sidewalk between East Rose Valley Rd and Copples Lane) within the coming year. A sincere "thank you" to State Representative Leanne Krueger and State Senator John Kane for their enthusiastic support of, and strong advocacy for, Nether Providence's grant applications in the Pennsylvania House and Senate. Check out the Township's website for more information on our continuing efforts to improve student and pedestrian safety in our community.

The Board welcomes and encourages resident questions or comments during the public comment segment of its public meetings every second and fourth Thursday of each month at 7:30 pm.

Thank you to all the volunteers who came out to help plant trees from Pennsylvania Horticultural Society on November 20th.









- Plowing cannot begin until there are at least 2" of snow, to prevent damage to the roads and the plows. Once the area is plowed, the driver will plow other areas, and then return as necessary. This is the same procedure as the other wards. It can take up to 6 hours to finish a full round of streets.
- Please understand that plow drivers never intentionally "plow anyone in." The plows
  have to push the snow to the side of the road to create safe travel lanes. Additionally, it
  would be simply infeasible for the plows to be lifted up at each driveway in the
  Township. Therefore, we recommend shoveling the end of your driveway after the
  plows have completed their routes. The plows will make at least two passes on each
  public road.

#### During the storm, please keep these points in mind:

- Stay off the roads unless necessary. This is for your benefit and the benefit of the first responders.
- If possible, please park your cars in your driveway to make plowing easier for our Public Works Crews. Please remember that even after the storm has ended, the Public Works crews will still have several hours of work left to finish plowing the roads curb to curb. PennDOT handles the plowing of the state roads (252, 320, Wallingford Ave, Turner, Brookhaven, Baltimore Pike, Beatty)
- If you experience a power outage, contact PECO at 800-841-4141
- For water emergencies, Aqua customers should call 610-525-1400. Chester Water customers should call 800-793-2323.
- -For police, fire, or medical emergencies, call 911.

#### **ENVIRONMENTAL ADVISORY COMMITTEE- EAC**

2021 has been a busy year for Nether Providence's Environmental Advisory Committee. The EAC has focused much of its effort on waste management and energy issues and has:

- Prepared a resolution for the Board of Commissioners to pursue a zero waste plan to reduce use of the incinerator in Chester City. The resolution calls for the EAC to provide ongoing recommendations for waste reduction and recycling measures.
- Reviewed the curbside recycling generated by township residents to improve participation and quality of recyclables while maintaining the cost savings generated through the contracting method implemented in 2020.
- Moved towards installing the township's first public electric vehicle charger and considered further locations as well as exploring funding for the purchase of electric vehicles for the township.
- Helped the township develop a simplified solar panel permitting process similar to Swarthmore's.
- Learned about Media's new borough-wide composting program as a possible model for the future.
- Followed Media's upcoming plastic bag ban with the hope of implementing one in Nether Providence next year.
- Worked with two Green Advisors from Swarthmore College to reduce waste from schools in the township.

The EAC will hold an annual strategy planning meeting at the Township building at 6 pm on December 15th. Anyone is welcome to attend and help shape the EAC's 2022 agenda. The EAC has a vacancy for appointment for anyone interested in the work we're undertaking.



# STORMWATER MANAGMENT





#### Winter Deicing Tips for Residents

Excess salt and other deicing chemicals can harm aquatic life in our streams and impact drinking water supplies. This winter, you can help by following these *environmentally-friendly* snow removal practices:

- Shovel snow before it turns to ice to <u>limit</u> the need for deicing chemicals like rock salt
- Shovel snow onto permeable surfaces including gently sloping and level land scape and grassy areas so as the snow melts it will soak into the ground rather than flow directly into a nearby storm drain or stream.

#### If you must use deicing chemicals, follow these suggestions...

- Control application of chemical deicers and avoid over application.
- Limit chemical applications near environmentally-sensitive areas including springs, streams, ponds, wetlands, and water supply areas and sensitive landscape and vegetation
- · Sand and sawdust can be used as an environmentally-friendly alternative to commonly used salt products.
- Use salt substitutes that are less harmful including Calcium Chloride (CaCl<sub>2</sub>) and Calcium Magnesium Acetate (CMA).
- For larger areas, apply salt as a brine solution to prevent drift off of paved surfaces.
- After snowmelt, sweep up residues, including sand, to prevent it from washing into storm drains and streams

#### Why should I limit my use of salt and other chemical deicing products?

Deicing products contain chemical constituents that can be harmful to the environment including water resources and drinking water supplies. For example, sodium can break down soil structure and decrease soil permeability, which adversely impacts vegetation and soil microbes; chloride mobilizes heavy metals and impacts fresh water supplies including ground and surface waters; and heavy metal components can adversely impact water quality, plant and aquatic life.



Leaking oil goes from car to street. And is washed from the street into the storm drain and into our lakes, streams and into coastal waters including the Chesapeake Bay.

Now imagine the number of cars in the area and you can imagine the amount of oil that finds its way from leaky gaskets into our water. So please, fix oil leaks.

#### **Township Projects Update**

#### **East Possum Hollow Sidewalk Project- UPDATE**

The construction of the East Possum Hollow sidewalk project was slated to begin in mid-October. However, the contractor for the project, Road-Con, decided at the last minute to move the project to the spring. Unfortunately, their contract with PennDOT allows them to do so, as long as the project is completed before June 30th. The Township challenged Road-Con several times on this decision as the information about the project's timing had been widely disseminated, but at this point in the season, we have not been successful in that challenge. As such, we will begin planning for their **spring start date**, which is now estimated for **mid-March**.

The Township will be installing a PennDOT-funded sidewalk on the train-track side of East Possum Hollow Road from Providence Road (Rte. 252) to the Wallingford Train Station. This is funded through the Congestion Mitigation and Air Quality program, which is meant to improve access to mass transit. During the project, East Possum Hollow Road will be one-way. Traffic will only be able to travel eastbound from Providence Road towards the train station/Kershaw Road. Traffic on Kershaw will be forced to turn right onto East Possum Hollow Road. We know this detour will be an inconvenience, but there will be many long-term benefits to safety and accessibility.

#### EAST ROSE VALLEY WALKWAY PROJECT-UPDATE

The Township has received grant funding for the East Rose Valley Pedestrian Walkway Improvements Project. The work will be occurring along the northern side of East Rose Valley Road from Osborne Lane to Providence Road, and will consist primarily of a path, Americans with Disability Act (ADA) ramps and drainage improvements. Traffic signal and ADA improvements will take place at the intersection of E. Rose Valley Road and Providence Road as well. The Township's Engineering Company has been working with PennDOT on the plans for the East Rose Valley pathway project. Unfortunately, PennDOT required several last-minute changes, which will mean another design resubmission to PennDOT. Since it is a State-funded project on a State Road, the Township has to comply with PennDOT's review comments. This is frustrating as it will push the construction's start date into early 2022, but we are looking forward to its completion.

#### **Township Projects Update**

#### **Gouley Park Streambank Project- Completed!**

This grant-funded restoration project included the stabilization of 300 feet of streambank, the removal of invasive species, and the removal of stream sediment. The finishing touch was the planting of 45 Trees!



#### Marijuana Decriminalization

At its November 18, 2021, Legislative Meeting, the Board of Commissioners moved and unanimously adopted an ordinance eliminating criminal penalties and establishing civil penalties for possession of a small amount of marijuana or marijuana products and paraphernalia in most instances. The Board of Commissioners thank Nether Providence Chief of Police, David Splain, for his input and his support for the legislation.
