

- Plowing cannot begin until there are at least 2" of snow, to prevent damage to the roads and the plows. Once the area is plowed, the driver will plow other areas, and then return as necessary. It can take up to 6 hours to finish a full round of streets.
- Please understand that plow drivers never intentionally "plow anyone in." The plows have to push the snow to the side of the road to create safe travel lanes. Additionally, it would be simply infeasible for the plows to be lifted up at each driveway in the Township. Therefore, we recommend shoveling the end of your driveway after the plows have completed their routes. The plows will make at least two passes on each public road.

#### During the storm, please keep these points in mind:

- Stay off the roads unless necessary. This is for your benefit and the benefit of the first responders.
- If possible, please park your cars in your driveway to make plowing easier for our Public Works Crews. Please remember that even after the storm has ended, the Public Works crews will still have several hours of work left to finish plowing the roads curb to curb. PennDOT handles the plowing of the state roads (252, 320, Wallingford Ave, Turner, Brookhaven, Baltimore Pike, Beatty)
- If you experience a power outage, contact PECO at 800-841-4141
- For water emergencies, Aqua customers should call 610-525-1400. Chester Water customers should call 800-793-2323.
- For police, fire, or medical emergencies, call 911.

## What to do if you've become a victim of a porch pirate

- Check with your delivery company to make sure your package was actually delivered.
- 2. Know exactly what's in the missing box.
- 3. If you see the thief, pay attention to what his or her vehicle looks like and its license plate number. Second to that, get the thief's physical description gender, approximate height and weight and what they're wearing so you can tell an officer.
- Call 911 and ask for an officer to come to your home.
- If you have a security camera on your home, get a copy of the video to police. Ask your neighbors if their cameras captured the thief in action.


#### **ENVIRONMENTAL ADVISORY COMMITTEE- EAC**

Nether Providence Environmental Update

As Township residents have continued to emerge from their pandemic hibernation there has been a lot of environment-related activity in Nether Providence in 2022. This summary is brought to you by the NPT Environmental Advisory Committee (EAC), but the list includes activities by the Township, other NPT Commissions, and citizen action groups.

- EAC members conducted Recycling Education Outreach at Family Fun Day, Unity Day, and with local Boy Scouts
- A coalition led by the Parks Commission, with support by the EAC, Shade Tree Commission, and Board of Commissioners applied for and obtained Bird Town Pennsylvania designation. Bird Town PA works in partnership with local municipalities and like-minded organizations to promote community-based conservation actions to create a healthier, more sustainable environment for birds, wildlife, and people. - The Board of Commissioners passed a Declaration of Arbor Day (in conjunction with the Bird Town application)
- The Shade Tree Commission sponsored two tree planting events
- A Waste and Recycling Committee consisting of two Commissioners and citizens from each ward was established to evaluate options for improvement of any/all aspects of waste collection/management and recycling. If you have ideas to share or wish to join the Committee, please contact your commissioner
- Through the Swarthmore College Green Advisors program, two energetic students mentored by an EAC member and the Township Manager are working with the Township on projects related to solar power for Township buildings and electrifying Township vehicles
- The EAC has been following the development of single use plastic bag bans in nearby communities including Media Borough (effective January 2023) and worked with Commissioners to draft a similar ordinance for consideration by Nether Providence
- · NPT hosted e-recycling and shredding events with other community partners
- $\cdot$  Township leaf collection and composting is a perennial success wrapping up with with a final pass through all wards the week of 12/12
- The Township has applied for recycling grants for replacement recycling containers and an additional leaf collection truck
- CAT Club of NPT (Citizens Against Trash) has conducted successful roadway trash cleanups throughout the year, with logistics support by NPT
- The township has received grants for trail improvements and watershed restoration in Houston Park.
- Through the Swarthmore College Green Advisors program, two energetic students mentored by an EAC member and the Township Manager are working with the Township on projects related to solar power for Township buildings, tree city certification and composting.

#### Winter Deicing Tips for Residents

Excess salt and other deicing chemicals can harm aquatic life in our streams and impact drinking water supplies. This winter, you can help by following these *environmentally-friendly* snow removal practices:

- Shovel snow before it turns to ice to <u>limit</u> the need for deicing chemicals like rock salt
- Shovel snow onto permeable surfaces including gently sloping and level land scape and grassy areas so as the snow melts it will soak into the ground rather than flow directly into a nearby storm drain or stream.

#### If you must use deicing chemicals, follow these suggestions...

- Control application of chemical deicers and avoid over application.
- Limit chemical applications near environmentally-sensitive areas including springs, streams, ponds, wetlands, and water supply areas and sensitive landscape and vegetation
- · Sand and sawdust can be used as an environmentally-friendly alternative to commonly used salt products.
- Use salt substitutes that are less harmful including Calcium Chloride (CaCl<sub>2</sub>) and Calcium Magnesium Acetate (CMA).
- For larger areas, apply salt as a brine solution to prevent drift off of paved surfaces.
- After snowmelt, sweep up residues, including sand, to prevent it from washing into storm drains and streams

#### Why should I limit my use of salt and other chemical deicing products?

Deicing products contain chemical constituents that can be harmful to the environment including water resources and drinking water supplies. For example, sodium can break down soil structure and decrease soil permeability, which adversely impacts vegetation and soil microbes; chloride mobilizes heavy metals and impacts fresh water supplies including ground and surface waters; and heavy metal components can adversely impact water quality, plant and aquatic life.

## Waste & Recycling Committee

The Township Board of Commissioners has established a committee to evaluate and make recommendations to the Board of Commissioners about the current and future state of residential waste collection and recycling in the Township, culminating in a public report. Areas of review can include ancillary residential waste-related concerns including yard waste, composting and leaf collection if the committee so chooses. The committee will hold public meetings and will be looking for input from residents.

#### PROPERTY TAX/RENT REBATE PROGRAM

The Property Tax/Rent Rebate program benefits eligible Pennsylvanians age 65 and older; widows and widowers age 50 and older; and people with disabilities age 18 and older. The income limit is \$35,000 a year for homeowners and \$15,000 annually for renters. Claimants may exclude half of their Social Security income. In addition, federal Civil Service Retirement System benefit recipients may exclude 50% of the average annual Social Security benefit amount from their total eligibility income and veterans with federal veterans' disability payments or state veterans' payments may exclude 100% of those payments. The maximum standard rebate is \$650, but supplemental rebates for qualifying homeowners can boost rebates to
