 - b. Drafting of ordinance
 - i. The Commissioners wanted to pursue the ordinance from the perspective of reducing the "nuisance" factor of unnecessary lighting as opposed to taking a full Dark Sky Model Ordinance approach, which may be difficult to objectively enforce.
