#### 5. Recycling Communications to Township residents

- i. Discussion:
  - 1. Stickers
    - 1. Discussed doing a small run, and putting the stickers to the inside of the lids
      - a. More specifically the major items to be included
  - 2. Swarthmore EAC did the following:
    - Articles in the Swarthmorean weekly newspaper: EAC members
      wrote articles about "Best practices for Recycling in Swarthmore" as
      a two-week series, and articles describing changes in recycling
      opportunities, such as the addition of the glass recycling bin at the
      Swarthmore recycling center.
    - Content on the Borough website: the above articles are linked on the EAC page of the borough website, and we work with borough administration to make wording changes to the content under their recycling tab.
    - Tabling at local events: the EAC has a table once a year at the Swarthmore Farmers Market and at the Swarthmore Charity Fun Fair in May. We have signs and handouts about recycling and talk to passers-by. As a draw to start these conversations, we have a recycling challenge "game" seeing if people can correctly place particular items in the recycling or trash.

- Social media: We post events and new information on the <u>EAC</u>
   FaceBook page. We also post on NextDoor.
- There are a few locations around town (library, flyer kiosk, food Coop) for posting events such as electronics collections.
- 3. Media EAC does the Following:
  - 1. The primary means of communicating to Media residents is via the borough's monthly newsletter. It is sent to about 11,000 people, residents and non-residents. It contains everything going on in the Borough. Here is a link to the January edition, the most recent.
  - 2. We also publish some information using the Borough's social media accounts. That tends to be briefer items and event updates. Both the newsletter and social media posts refer back to the Borough's web site. We'll generally only use social media and the newsletter no more than once a month. We don't have direct access to the newsletter, web site and social media. Our updates go through borough administration. They are all approved by borough administration
  - The borough's web site has a calendar of events and sections for different borough committees such as the EAC, the Recreation Board, etc. For the EAC, the web site is the primary source of documents such as what is recyclable, FAQs and so on.
  - 4. We also communicate to businesses via the Media Business Authority (MBA) and meetings directly with Media businesses. We will, as needed, do group meetings via Zoom, etc.
  - 5. Regarding your example topic, recycling communications: if we wanted to remind residents about changes, we'd have the borough web site updated, then depending on the timing, we request social media posts and a newsletter article. If we just wanted to remind people of what is/is not recyclable, we'd probably just request social media post
- 4. There are mailing lists within NPT
- 5. Discussed putting recycling in a plastic bag
  - 1. The plastic bags do not get included with the recycling at the plant
- 6. Discussed education and enforcement
  - 1. Can ask them to make a list of things they are seeing around town and we can add that information to communication to the residents
- 7. Discussed updating the website information on Recycling information
  - 1. To make it more prominent (Spotlight)
  - 2. Need to identify the permanent recycling box
- 8. Include this information in the Newsletter in June
  - 1. Remember:
    - a. No greasy Pizza Box
    - b. No Plastic bags full of Recycling the plastic bags and contents are not included in recycling

- 9. Discussed invoices from "Republic"
  - 1. The invoices received appear to be flat and lack more disclosure
  - 2. They charge \$105/ton
    - a. We need to see what was in the RFP Bill
    - b. Maureen is better with information like this
