1. Recycling RFP and Next Steps

- Audit in the first 30 days in contract annually.
- Bill said they bill us on recyclables not residential mix. We get a \$20 credit

Food recovery pilot program - Action Plan

- In accordance with Resolution No. 2021-9 to hereby establish a recommendation for the Nether Providence Township Zero Waste plan - the Nether Providence EAC hereby proposes a food recovery pilot program.

1. Check Existing Logistics for Food Recovery

- **Deadline:** February 21, 2025 - Completed on February 20, 2025 at Salvation Army Chester Corp and March 6, 2025 at Lifewerks, Inc.
- **Parties Responsible:** Chris Mano, Vice Chair of NP EAC
 - Review existing processes and infrastructure for food recovery in the community.
 - Research existing models in neighboring municipalities for insights.

1. Confirm Logistics with Community Partner for Pick-ups and Deliveries of Items

- **Deadline:** March 3, 2025 - Completed February 27, 2025 by email.
- **Parties Responsible:** Chris Mano, Vice Chair of NP EAC
- Confirmed the logistics with Lifewerks regarding:
 - Preferred days and times for food donations drop-offs.
 - Clarify how donations will be handled once they arrive.
- 1. Recruit Small Team of 3-5 EAC Volunteers for Food Recovery Task Force
- **Deadline:** By March 31, 2025 - Completed.
- **Parties Responsible:** Chris Mano NP EAC Vice Chair
 - Recruit 3-5 EAC volunteers to form a task force that will be responsible for:
 - Collect donations at designated locations.
 - Sort and categorize the donated food.
 - Ensure that food is delivered to the Salvation Army or any other designated partner.
 - Assign roles for sorting, managing logistics, and communicating with the public and Salvation Army.

1. Community Outreach by Announcing the Food Recovery Drive Collection

- **Deadline:** By April 30, 2025, for promotion - Update
- **Parties Responsible:** Chris Mano, Vice Chair of NP EAC and interested EAC Members.
 - Flyers: Design and distribute flyers around the community (township building, community centers, schools, etc.) announcing the food drive and listing the items to donate and any guidance.
 - Social Media: Post on township and EAC social media pages announcing the event. Include key details, donation guidelines, dates, and collection point(s).
 - Community Meetings: Announce the food drive at any upcoming community or EAC meetings.
 - To include this information Spring Newsletter (April 1): Include information about the food drive in the spring newsletter to raise awareness and encourage participation.
- Assist in Collection, Sorting, and Distribution to Lifewerks

- Deadline: **May 2, 2025 or May 9, 2025 - Finalize Update after meeting**
- **Parties Responsible:** EAC Task Force Members
 - Start collecting donations from the community and ensure they are organized at a central location (such as the township building or other designated spot).
 - Use a table for volunteers to organize donations by type.
 - Deliver the sorted donations to the Salvation Army or another vendor (Philabundance) on the agreed-upon schedule.
- Evaluation of the Pilot Program After 3 Months
- **Deadline:** **By July 30, 2025 - Update**
 - **Track Metrics:** Keep a record of the total amount of food donated, how much was diverted from landfills, and the number of families served.
 - **Community Feedback:** Collect feedback from participants and volunteers to assess the success and any challenges.
 - **Metrics and Reporting:** Prepare a public report or update to share with the community, township officials, and on social media. Include both quantitative (pounds of food, number of people served) and qualitative (feedback, challenges, successes) data.
- **Potential cost-savings for the Township:**
 1. [PA Department of Environmental Protection \(DEP\) Recycling Grants](#)
- Municipal Waste Planning, Recycling, and Waste Reduction Grants support local governments in developing and maintaining recycling programs, which may include food recovery and waste diversion efforts. Although food recovery is not always the primary focus, we can explore whether the program's flexibility allows for food waste initiatives. The DEP provides funding annually, and the applications are typically available in the fall. Local governments can use these funds for equipment, education, or program development.
- 2. Food Waste Reduction Grant Program
- [PA Department of Environmental Protection \(DEP\) Waste Reduction Programs](#) focus on reducing food waste, including initiatives to improve food recovery and divert food from landfills. The state encourages local governments and organizations to seek grants for projects that focus on sustainable waste management practices, which could include food recovery.
- 3. Local Government Advisory Services and Technical Assistance
- The PA Department of Environmental Protection (DEP) offers various [technical assistance](#) resources, including help with setting up waste diversion programs, evaluating the effectiveness of food recovery programs, and connecting municipalities to nonprofit organizations such as Philabundance.
- 4. Recycling and Waste Diversion Programs - Solid Waste Advisory Committees (SWAC)
- [Solid Waste Advisory Committees:](#) These committees often provide grants or financial support for municipalities involved in waste diversion, recycling, and sustainability projects. This could be another avenue to explore when seeking resources for a food recovery program.
