**4. New Business:**

- i. Free the trees event (where they clear ivy from trees)
  - 1. From Paul's communication with Rose Valley EAC:
    - 1. They have 4-5 organizing volunteers who pick a site and work with the community to find more volunteers.
    - 2. They've had hundreds of volunteers and cleared thousands of trees
    - 3. The event is held in April. This is critical because it's before the trees (and poison ivy) leave out, but it's warm enough
    - 4. They mark trees to be cleared with plastic ahead of time and count how many have been cleared. Some people find it fun to get a bunch cleared
    - 5. I have a flyer and guide from her
    - 6. She gets tool from a "tool library" available for free, but which requires reservations
  - 2. Dan informed Ian Springer, NPT Shade Tree Committee Member
  - 3. Currently looking for someone to help with leading the volunteers
    - 1. Paul is thinking of kicking off something in the upcoming Spring, 2026
    - 2. Planning for that will begin now so there is time to recruit volunteers
  - 4. Shaina: The township is working on this.
  - 5. Involve the School - Speak to Traci
- ii. Delaware County Office of Sustainability's EAC Hub Project:
  - 1. Will go live on January 14, 2026
  - 2. An information repository for the use of all entities looking to make change in environmental and climate policy space at the local government level within Delaware County, PA.
  - 3. This includes, but is not limited to EACs, Conservation Committees, Shade Tree Commissions, Open Space Committees, and municipal staff.

## New Small E-waste Collection Container

**Nether Providence Township is excited to announce a new small e-recycling service for residents with drop-offs on Monday and Tuesday from 8:00 am -2:00 pm and the first Saturday of the month from 8:00 am-noon.**

**Located at 5 W Brookhaven Rd in the Public Works recycling area**



NPT has expanded its partnership with PAR-Recycle Works to add this new service in addition to our annual E-recycle/shredding event. PAR recycling is a non-profit electronics recycler that provides employment and services to people returning from prison. This container is for any small and medium-sized items with a plug or wire. The items must fit & cannot be left outside the container.

PAR recycling is R2-RIOS certified. Which means the R2v3 recycling results in zero landfill destination for e-waste and provides a common set of processes, safety measures and documentation requirements for businesses that repair and recycle used electronics. PAR does corporate and personal pick ups too!

E-Recycling service is provided by **PAR RECYCLE WORKS** – a local nonprofit that sells reusable materials collected from electronic devices to help pay for salaries and job skill development for formerly incarcerated men and women, in order to support their productive re-entry back into society. We will gladly accept the following items at no charge:

Printers; Mice; Keyboards; Monitors - LCD flat-screen; AV equipment; Phones; Speakers; Motherboards; Hard Drives; Power Supply Wire - chargers, connectors, etc.; Computer Batteries; Laptops; Gaming Equipment; Routers; Server Cabinets; Floppy Disks; Docking Stations; Miscellaneous computer-related materials

\*\*Because of environmental issues that make safe disposal expensive, there is a fee for the following items:

- Older CRT Monitors and TVs: \$40 - \$80/each, cost varies by size;
- Flat Screen TVs: \$25;
- Computer Monitors: \$7;
- Air Conditioners, Dehumidifiers, & Air Purifiers: \$25;
- Microwaves: \$15.
