- i. Lower Merion Township Approves Gas Blower Ban:
 - 1. Discussion:
 - a. Lower Merion Township has recently approved a ban on gas-powered leaf blowers, following a public comment period.
 - b. The ordinance will phase out gas-powered leaf blowers from specific seasons in 2026, 2027, and 2028, with a complete ban starting in 2029.
 - The ban aims to create a cleaner and quieter environment by reducing noise pollution and air pollution.
 - d. Violators may receive a warning before facing fines, with escalating penalties for repeated violations.
 - e. This decision marks Lower Merion Township as the first in Pennsylvania to implement such a ban, reflecting a growing trend among suburban communities to promote environmentally friendly landscaping practices.
