2. Outdoor gas powered equipment
 1. Some research happened since May and a few grants were identified.
 2. One township implemented a rebate program with a grant that allowed them to give back money if people purchased electric lawn equipment
 3. Two things that would reduce use: less lawns and "leaving the leaves" in the fall, which provide a habitat for native insects

 3. The EAC Speaker Series
 1. We discussed the need to make a flyer. Jenny volunteered to help create one, focusing on the first four events in one flyer.
 - a. Once we have created Flyers, we will ask the Township and Commissioners to advertise among their constituents
